3. Registration Form alongwith payment must be submitted in shape of Bank Draft/Pay Order in the name of **DCK HOUSING APPLICATION**. Incomplete form will not be accepted.
4. Branches of Askari Bank Ltd, Bank Al Habib, Dubai Islamic Bank and MCB Bank Ltd will accept the Registration Form alongwith Pay Order / Demand Draft.
5. Each Registration Form is for one Farmhouse only. One person can apply for one Farmhouse in each size category only
6. After submission of Registration Form, the registration will remain non-transferable.
7. Allotment of Farmhouse will be through balloting. Ballot result will be announced on DHA Karachi website on next day of Ballot.
8. Deposited amount, except the processing fee, will be refunded to the unsuccessful applicants after 90 days of the ballot.
