Administrative Officer

General

- 1. Only those person are eligible who are allotted property through special allotment.
- 2. Membership fee, advance Development charges and mosque fund to be paid with the application through Bank Draft/Pay Order in favour of DHA City Karachi (Mosque Fund not applicable to non Muslims).
- 3. All attached documents should be duly attested by Oath Commissioner/Town Nazim/Magistrate Class-I, Gazetted Officer (Garde-17 & above).
- 4. Original CNIC MUST be in possession while appearing before DHA Designated Officer.
- 5. Category 'S' (ESS) member is desirous of purchase other plot, will be required to obtain separate membership.
- 6. This Membership is valid till disposal of property acquired through Category 'S' membership and renewable after every 05 years till disposal.
- 7. Applicant is required to appear personally before the DHA designated officer for signatures, digital photographs and digital fingerprinting.
- 8. Any observation noted at the time of sign before has to be rectified prior to proceed further.

COMPLETION OF FORM

- 1. In case of more than one marriage, details of all wives are required.
- 2. All attached documents must be readable.
- 3. No overwriting/cutting/erasing is acceptable.
