- 2. <u>Car Stickers.</u> All existing Car Stickers for the vehicles of DAMC Members have expired on 31 Dec 2019. Members are informed that car sticker forms are available at DAMC Accounts Office. New stickers will be issued after production of copy of vehicle registration along with car sticker form dully filled and signed by the member. Entry of members' vehicles in the Club with old stickers will not be permitted. All members are requested to get their stickers renewed to avoid inconvenience, please.
- 3. Permanent Membership. After completion of 5 years of "Regular" membership a member may apply for permanent membership after depositing requisite fee i.e Cat-A Rs 50,000/- and Cat-B Rs 100,000/-, fulfilling certain conditions i.e consistent good discipline, owning a boat, regular in payment, conduct of household members, frequent utilization of club facilities etc. A permanent member is entitled for certain advantages like eligibility for selection as a member of Club's Executive Committee and privilege to "Propose" or "Second" candidates for membership of DAMC. Regular Members vying for Permanent Membership may apply in an early timeframe so that the cases can be processed in forthcoming Club Executive Committee Meeting.
- 4. <u>Transfer of Membership to One of the Son/ Daughter.</u> Permanent Members of the Marina Club having attained an age of 65 years and above may transfer their membership to one of their sons/ daughters on following rates:
 - a. <u>Category A.</u> 15% Entrance fee and 15% security deposit of prevailing rates for Category B membership fee.
 - b. <u>Category B.</u> 20% of Entrance Fee and 20% of Security Deposit of prevailing rates for Category B membership fee.

Interested members may forward their applications in an early date so that necessary formalities may be completed before processing their transfer case in the forthcoming Club Executive Committee Meeting.

- 5. <u>Independent Membership for Ex Household Members.</u> Ex household members of the Club have a privilege to become independent Regular Members of DA Marina Club on subsidized rates. Interested members who want to avail this opportunity, may contact Club administration so that their independent Regular Membership may be processed in the forthcoming Executive Committee Meeting (ECM).
